Decisions:

- 1. No conflict of interest declared by MC members;
- 2. 2nd call: Proposal to select 122 proposals accepted. Final selection foreseen for the next MC meeting in November;
- 3. Evaluation plan and 2023 communication plan presented;
- 4. IPA Financing agreements: all hard copies already signed by EC and MA and recently received by IPA countries, signature procedures ongoing. Process of some months for AL, MN, NMK. For BA, very long national procedure including a ratification, problems may arise for concerned partners. MA will ask a legal opinion whether the AcA can start payments after signature but before ratification.
- 5. Management and control system state of the art: 1st version of the Management and control systems description ready (as by regulation end June) and sent to the AA. Exchanges with the AA started. Once consolidated, will be presented to MC for validation as foreseen in FA. On this basis, AA should carry out system audit. Concerning Programme Manual, last package (project modification/closure and harmonization) foreseen in autumn.
- 6. Jems: roadmap presented. National Controllers network proposal to add functionality for upload and storage of expenses supporting documents discussed and approved. JS/MA will verify legal modalities to modify the existing public procurement for Jems.
- 7. Proposed definition of enlargement of MC (art. 8.1 CPR regulation) approved. Modification of the MC Rules of procedure also approved adding modification of art.7 to let JS proposes working groups when justified.
- 8. Communication strategy approved
- 9. MC physical meetings: no decision yet
- 10. TA 21/27: Written procedure on updated distribution of TA budget to be sent soon. Reimbursement procedure to be presented at the latest during next MC meeting in November.
